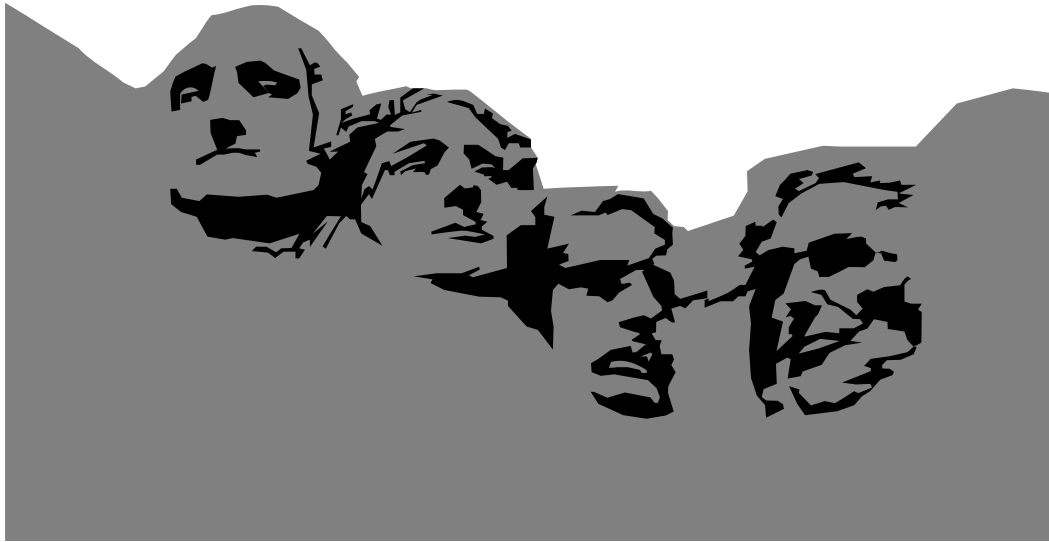


# SOUTH DAKOTA SALES and USE TAX REPORT
